Brief about the Standards adopted

The Web Content Accessibility Guidelines (WCAG) are the internationally recognised technical standard for digital accessibility, developed by the World Wide Web Consortium (W3C). Our website adopts WCAG 2.2 (W3C Recommendation) at conformance Level AA.

WCAG is built around four core principles — that digital content should be:

- **Perceivable:** Information and user interface components are presentable to users in ways they can recognize and process.
- **Operable:** User interface components and navigation are functional and easy to interact with.
- **Understandable:** Information and the operation of the user interface are easy to comprehend.
- **Robust:** Content is compatible with a wide variety of user agents, including current and future assistive technologies (like screen readers).

We have targeted for the following levels of standards criteria:

- Level A (Minimum): The baseline level of accessibility; addresses basic web accessibility features.
- Level AA (Standard): The accepted standard for most websites and legal requirements (also referenced under applicable SEBI circulars)
